 - Conditions of the offer: BA Degree (Grade: 70%) + IELTS academic (7.0) -- 7.0 in writing and 5.5 for all the rest
- SAOS University of London
 - Programme: MA Human Rights Law
 - Conditions of the offer: BA Degree (Grade: 13/20)
